

## TERMS & CONDITIONS OF USE

The Round & About Dining Club Terms & Conditions are listed below. If you have any questions about these Terms & Conditions please contact us at the address below

1. The membership card can only be used by the named cardholder.
2. The Membership Card is issued by and remain the property of Round & About Publications Limited which reserves the right, at any time without notice, to: (a) terminate the scheme; (b) decline to issue a Membership Card; and (c) on reasonable grounds, withdraw or cancel Membership Cards, or to alter or amend the conditions of operation of the Round & About Dining Club Scheme. Reasonable grounds include (i) any abuse or attempted abuse of the scheme, or (ii) any use or attempted use of a Membership Card in a manner which is contrary to these terms and conditions or (iii) any reasonable suspicion of dishonesty on the part of a member in connection with the scheme, or (iv) any reported damage or anti-social behaviour by a card holder reported by a member establishment.
3. All participants in the Round & About Dining Club scheme must be resident in the UK and aged 18 years or over.
4. The Round & About Dining Club Card are not transferable, and can only be used by the person whose name is on the card.
5. Members may be removed from the scheme at any time at the discretion of Round & About Publications Limited.
6. Your Round & About Dining Club Card can be used to get a minimum discount of 10% off your food bill, when a minimum of 2 people order 2 courses each (subject to additional terms, offers & discounts on a per establishment basis) and detailed on the member establishment listing on [www.eatoutlocally.com](http://www.eatoutlocally.com).
7. Your Round & About Dining Club Card cannot be used as a credit card or a guarantee card and does not have any monetary value.
8. The Round & About Dining Club card remains the responsibility of the main Cardholder, and any lost or stolen cards cost £5 to re-issue.
9. The Round & About Dining Club Card must be shown to a member of staff before placing your order.
10. The Round & About Dining Club Card is valid for 1 year, from date of issue, and the expiry date of the card is printed on the reverse of the card, after which it must be renewed at [www.eatoutlocally.com/club](http://www.eatoutlocally.com/club). Every effort will be made to remind a member that their membership is coming to an end, but it is not our responsibility if the membership lapses. All changes of address must be notified through the website or in writing to the address below
